## **Terms and Conditions**

### **1. The Contract**

- 1.1. These Terms and Booking Conditions must be signed before the booking is secured. Signing these terms and conditions represents a binding agreement between you and Barons Farm and cannot be varied except in writing.

### **2. Supply of Services**

- 2.1. Barons Farm shall provide the services (accommodation, breakfast etc.) agreed above. Any variation to this must be agreed in writing. Breakfast will only be provided for guests who have paid to stay.
- 2.2. Barons Farm may at any time, without notifying the client, make any changes to the services which are necessary to comply with any applicable safety or other statutory requirements, or because of any external supply difficulties and to make any other changes which do not materially affect the nature or quality of the services. Barons Farm shall make reasonable endeavours to communicate any such changes to the client prior to the client's event.

### **3. Charges**

- 3.1. The charges payable by the client shall be provided in writing. If no charges are specified, the client shall pay the standard charges at the prevailing rate when staying.
- 3.2. Barons Farm may vary the standard charges from time to time and reserves the right to alter prices associated with any stay at Barons Farm's discretion. Where time permits, Barons Farm shall endeavour to advise the client of any price variations prior to providing the services.

### **4. Payment**

- 4.1. Payment to Barons Farm by the client must be made in cash at your two-week meeting.
- 4.2. Any additional charges due shall be paid by the client on presentation of an invoice or bill.

### **5. Cancellation Charges**

- 5.1. All cancellations must be notified in writing to Barons Farm, on receipt of which Barons Farm reserves the right to enforce this contract.
- 5.2. The applicable notice periods and associated costs are the same as those agreed between the client and The Wellbeing Farm for your wedding.
- 5.3. Non-arrival by a client (whether the whole party or part of a party) on the contracted date will be treated as cancellation.
- 5.4. If Barons Farm for reasons beyond its control needs to cancel a booking, we will attempt to arrange alternative accommodation.

### **6. Liability**

- 6.1. We do not except liability for any damage, loss or injury to the client or any member of your party or

any vehicles or possessions, unless proven to be caused by a negligent act by ourselves. The management accept no responsibility for any valuables or other personal property left unattended in any area.

- 6.2. No candles, fireworks, sparklers, cigarettes (or e-cigarettes), lighters of any kind to be brought into or used on Barons Farm. A smoking area is provided outside the premises.
- 6.3. The client is responsible for all damage and breakages incurred during the client's stay (even if not discovered until a later date) and Barons Farm reserves the right to charge the client the cost of replacing any items that are removed from the premises by the client or their guests without consent. The charge will be the cost of a full replacement including any associated costs.
- 6.4. The client is responsible for their behaviour and the behaviour of their guests at Barons Farm. The client must ensure that no noise or nuisance is caused to neighbours. The client must comply with any reasonable request of Barons Farm and with any policies of Barons Farm.
- 6.5. All vehicles are parked at the owner's risk. Should a problem occur with a vehicle in Barons Farm's car park, Barons Farm cannot accept any liability.

### **7. Termination**

- 7.1. Barons Farm may (without limiting any other remedy) at any time, terminate the agreement by giving written notice to the client if the client commits any breach of these terms that the client does not remedy within a reasonable period of time or if the client goes into liquidation, becomes bankrupt, makes a voluntary arrangement with its creditors or has a receiver or administrator appointed.

### **8. General**

- 8.1. Guests can check in from 5pm on the day booked and must check out before 11am. Subject to express agreement between you and Barons Farm.
- 8.2. No failure or delay by either party in exercising any of its rights under the agreement shall be deemed to be a waiver of that right, and no waiver by either party of any breach of the agreement by the other shall be considered as a waiver of any subsequent breach of the same or any other provision.
- 8.3. English law shall apply to the agreement, and the parties agree to submit to the non-exclusive jurisdiction of the English courts.
